Our District leadership team identified literacy as our academic focus. We focused our PD and collaboration time on that this year with our 2-hour late starts and some of our in-service day time. We used Ohio's Science of Reading PD. Elementary teachers realized they needed a literacy curriculum that pulled all the pieces of reading and writing together. That curriculum has arrived. Middle school teachers heard good feedback about the curriculum, so they reviewed the middle school version of the same curriculum and decided they wanted to adopt that. So we are now adopting the reading curriculum for middle school as well. Having a curriculum adoption is a really big accomplishment for our district. A big thanks to the staff who worked on that.

At the May Board meeting I shared our celebrations for the state test results we got back for math, science, and social studies. At that time, we didn't have English Language Arts scores yet. We now have those, so I wanted to update the Board and share more good news related to our academic achievement. In all tested grades 3rd through high school, scores increased over our own performance last year. That includes double-digit improvement in any areas. 3rd grade went up 16%, 4th grade up 10%, 6th up 21%, 7th up 11%...just to name a few. In every tested grade except one, we are outperforming the state. Scores in 3rd grade went up 46% from fall to spring - with the same kids! Shout out to the staff who worked so hard together to raise literacy achievement! This makes a difference for kids!
